RE: PROPOSED RESIDENTIAL MIXED USE SCHEME AT CITYWEST SHOPPING CENTRE, FORTUNESTOWN, DUBLIN 24 - STRATEGIC HOUSING DEVELOPMENT, PLANNING APPLICATION (Pre-Application Ref. ABP-304454-19)

Please accept this copy of a SHD planning application made by Tom Phillips + Associates to an Bord Pleanála, on behalf of OBSF(I) Limited<sup>1</sup> in respect of a strategic, zoned site at Citywest Shopping Centre, Fortunestown, Dublin 24.

This application is made in accordance with the provisions of the *Planning and Development (Housing)* and *Residential Tenancies Act 2016* ('the 2016 Act') and the Planning and Development (Strategic Housing Development) Regulations 2017 ("the 2017 Regulations"). The proposal will consist of a mixed use residential scheme (total GFA 26,929 sqm) comprising 6 no. blocks with balconies / terraces to be provided on all elevations at all levels for each block, to provide 290 no. apartment units and associated residential amenity facilities, a childcare facility, 4 no. retail units and 2 no. café / restaurant units. on a site of c. 2.9 ha. This planning application is made in accordance with the provisions of the *Planning and Development (Housing) and Residential Tenancies Act 2016* ('the 2016 Act') and the *Planning and Development (Strategic Housing Development) Regulations 2017* ('the 2017 Regulations').

A full schedule of all contents of this submission is appended to this Cover Letter.

We confirm that some 8 no. hard copies have been prepared in total. Two no. copies have been prepared for submission to An Bord Pleanála, six no. copies for South Dublin County Council.
